On February 5, 2018, the compensation committee of the issuer's board of directors certified achievement of the performance criteria at 134.2% of the target level, which will result in the vesting of the option with respect to 335,500 shares on March 5, 2018 and 335,500 shares on March 5, 2019, in each case subject to the reporting person's continued service to the issuer through such vesting date.
